Aims & Objectives:	To develop key skills through the experience of work. To gain an insight into working in aeronautical engineering.	
Key Tasks:	There is likely to be a high degree of observation on this placement, then after training students may be able to assist with basic tasks around the workshop. Your tasks may include assembly and disassembly of parts, the cleaning of components and the chance to shadow or help engineering staff. You will also be shown the types of exams that have to be completed on a regular basis.	
Requirements:	Should have common sense, confidence and initiative with a genuine interest in this work. Should be able to communicate well and follow rules closely.*This may not be a suitable placement for students with skin conditions.	
Clothing:	Student should dress in old clothes. Overalls will be provided. Steel toe capped boots are needed which are available at the Careers Office on deposit telephone 706567.
