## Guernsey Music Bursary LBG

The bursary, which is intended to assist students with the cost of instruments, study materials, books, tuition fees, etc., will be offered with effect from September /October 2024 and will be awarded in an amount of up to £2,500 per annum.

Subject to satisfactory performance (and the assessment of Guernsey Music Bursary LBG, whose decision shall be final) the bursary will continue for the duration of the course, up to a maximum term of four years.

Applications are invited from students who have been offered a provisional or confirmed place at, or who already attend, an accredited specialist conservatoire or a college or university to undertake specialist music studies, either instrumental or vocal. The successful applicant may be asked and should be prepared to participate in publicity in connection with the awarding of the bursary. Applicants should be residents of the Bailiwick of Guernsey.


